About

Midwest Small Business Finance (MSBF) maintains its own direct loan program, which is the Revolving Loan Fund (RLF). Repayments from loans are returned to the fund to be loaned out again. The focus of this program is to assist existing eligible small businesses located in Clay and Platte counties of Missouri.

Loan Size

Loan amounts range from \$25,000 to \$150,000+.

Use of Proceeds

Proceeds from RLF Loans must be used for fixed asset projects such as purchasing land, buildings, equipment, furniture, fixtures and leasehold improvements.

Terms, Interest Rates and Fees

Low market rates are fixed for the term of the loan. A low down payment of 10% is available on eligible project costs. Long-term financing up to ten years is available. Fees and closing costs can be added to the loan.

Collateral

Generally, the project assets being financed are used as collateral. Personal guarantees of the principal owners are also required.

Eligible Business

To be eligible, the business must be operated for profit. Startups will be considered on a case-by-case basis. Eligible businesses include manufacturing, processing or assembling of products; service-business operations and retail. Creation of qualified jobs is a criteria.

To start the process, an applicant should first contact Midwest Small Business Finance's staff to determine eligibility, availability of funds and the current rate. Borrower is required to complete a loan application.
